NOTICE OF RACE

I - ORGANISING AUTHORITY

The Coupe Internationale de Bretagne will be organized in Douarnenez Bay from Saturday 1st to Monday 3rd of May 2010, by the Société des Régates de Douarnenez, affiliated to the French Sailing Association.

II - RULES

The Regatta will be governed by the ISAF (RRS) Rules, the rules of the International Dragon Association (article 13.30 will apply), this notice of race, the sailing instructions and annexed rules.

III - ADVERTISING CATEGORY

This event is classified category A as per rule 20.3.2 of the ISAF (RRS) rules. Paragraph (d) (i) of rule 20.3.1 will also apply.

IV - ELIGIBILITY

The Coupe Internationale de Bretagne is open to any Dragon up to date with its obligations in the International Class and with its national authority. The valid and full registration / measurement certificate shall be presented to the organisers. The number of entries is limited to 105 Dragon.

V - ENTRY FEE

The entry fee is 130 € payable to the Société des Régates de Douarnenez.

This fee includes launching at the beginning and the hauling out at the end of the regatta, berthing in the Tréboul Marina at the front of the Club House until May 4th, 3 entries for competitors to each official function and complementary cocktails.

VI - ENTRY

Entries will be registered in the order of reception of the enclosed entry form, which must be accompanied by the entry fee. A copy of a valid and full measurement certificate will be required at the time of registration in Douarnenez as well as your insurance certificate.

Registration will close on 30th April 2010.

The sailing instructions will be available at the time of registration in Douarnenez. Only those entries which are cancelled before 15th March will be refunded.

VII - LIABILITY - INSURANCE

The safety of a yacht and its entire management shall be the sole and inescapable responsibility of the owner or owner representative. Yacht owners and competing crews must ensure that they are adequately insured against loss, damage or injury to persons, yachts or equipment at any time, however occurring, and maintain third party insurance of not less than 1 600 000 \in from arrival to the time of departure from Douarnenez. The organisers will require a written proof of insurance at the time of registration. No responsibility will be accepted either by la Société des Régates de Douarnenez or any party involved in the organisation of the regatta.

VIII - SCHEDULE OF RACES

Five races will be sailed from Saturday 1st to Monday 3rd of May 2010. First warning signal on Saturday 1st of May at 2.30 pm. Three races are necessary to validate the regatta. If 5 races have not been sailed, additional ones may take place on Tuesday 4th at the race committee's discretion.

IX - COURSE

The course will be windward - leeward type, to be completed in 1 h 30 to 2 hours.

X - SCORING SYSTEM

The low point scoring system A4.1 of the ISAF (RRS) rules will apply. <u>None of the races will be discarded</u>.

XI - PRIZES

The *Coupe International de Bretagne Trophy* will be awarded to the overall winner. Special prizes will be given to the next two yachts in the overall ranking. A prize will be given to the winners of each race.

XII - RIGHT TO USE NAME AND LIKENESS

In participating in the Coupe Internationale de Bretagne, a competitor automatically grants to the organising authority and the sponsors of the event, the right in perpetuity, to make, use and show, from time to time and at their discretion, any motion pictures and live, taped or filmed television and other reproductions of yacht and crew during the period the competition in which the competitor participates in and all material related to the said Coupe de Bretagne without compensation.
